

**BERKSHIRE HATHAWAY HOMESERVICES PREFERRED REAL ESTATE KICKOFF KID SWEEPSTAKES OFFICIAL RULES AND REGULATIONS – AUBURN UNIVERSITY - NO PURCHASE NECESSARY.**

Upon prize forfeiture, no compensation will be given. The winner must be available for the game date and time awarded and is responsible for transportation to and from the game.
